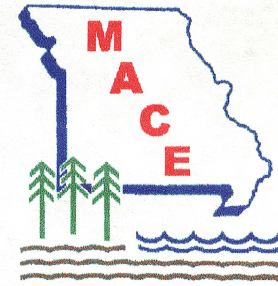

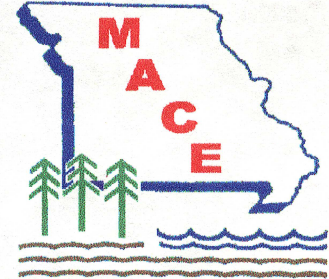
**2nd Vice President:** Shall preside in the absence of the 1st Vice President, and in the absence of the president of all MACE functions. Chairs the education committee

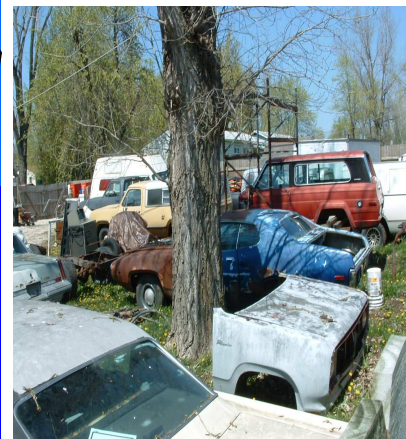
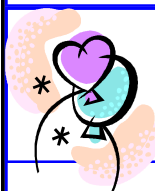

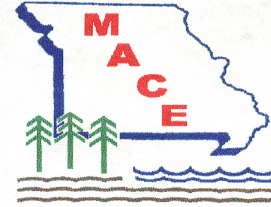
**ICC Chapter Members!**
